PORT OF ORCAS Minutes of the Regular Meeting November 9th, 2017

Call to order and confirmation of a quorum

The meeting was called to order at 4:30 P.M. in the Port conference room by Chair Brian Ehrmantraut. A quorum was present. Attending were: Ms. Martha Farish, commissioner from Orcas Island Parks and Recreation. Airport Manager Tony Simpson was also present.

Approval of Minutes

- 2. <u>Guss moved, Hopkins seconded adoption of Resolution 11-09-2017C, Resolution Adopting the 2018</u> <u>Budget</u>. The floor was opened for Public Hearing but no public arose to address the commission. The <u>question was called and carried unanimously.</u>
- 3. <u>Guss moved</u>, Wells seconded adoption of Resolution 11-09-2017C, *RCW 84.55.120 Levy*. The question was called and carried unanimously.

- 1. <u>Sawyer moved</u>, Wells seconded adoption of Resolution 11-09-217A, *Deferred Compensation Program* (*DCP*) without employer matching. The question was called and carried unanimously.
- 2. <u>Hopkins moved</u>, Wells seconded to approve extension of the FedEx Lease as written and authorized the Airport Manager to sign on behalf of the Port. The question was called and carried unanimously.
