



## MANAGER REPORT 2021 JUNE-Revised

- Our law office called to say that James and Jeannie are not allowed to have retroactive pay for annual wage increase that was delayed in awarding it. James will have 3 months of pay deducted from June Paycheck; Jeannie will have 2 months deducted from June paycheck. They also said that we are not allowed to increase Commissioner's meeting pay from \$114 to \$128 until the beginning of the new year 2022.
- Noise complaints are starting back up as expected with the visitors to the islands, increased freight and packages, increased passengers. Please look at [flightradar24](#) (free website) if you would like to track who is flying around and their altitude. Please feel free to call or email me to help with the research. If anyone is leaving a voicemail complaint, please leave your name, phone number, date, and time of the incident. As a reminder, I have installed signs at the runway entrances, posted on Facebook on a page that most Washington pilots follow and send out letters frequently all to help with the low or low flights. I was one of those people myself that did not know about our Noise Abatement Procedures several years ago. Anyone can make a complaint to the FAA as well for unsafe acts. ## FACILITY REPORT

- The replacement camera system is in the process of being installed. We have one more visit from contractor to install the East facing camera of Mt. Constitution and then we will be online for sharing. The quality of the picture is very good, and this will help pilots see what the weather is really doing here at the airport. The old system is over 10 years old, and the quality of the picture was very dark.
- Quote for asphalt in the North parking lot came in \$5800. This is help to keep rocks off the taxiways in the hanger area.
- I am still pending a quote for the ditch cleaning and clearing.
- We have sold out all the twin engine tie-down annual spots at the airport. It is going to be a very busy summer. Campers have started to arrive during the week now. The visitors really appreciate the bicycles the community donated as well as the courtesy car.
- I am working on a date for the credit card machine install for the fuel pump. The fuel company has told me several times that it is unsupported when I needed to make an update to it. CARES will be used to reimburse this project.
- James our Facility manager has had two needs that will help with operations. One is the replacement of our large grass mower. He is looking into the cost to bring to the Commissioners for approval. It is being repaired often and is old. CARES funding is available for reimbursement.
- James has also recommended that we move a part of the deer fence because it is currently going through the center of a pond. In the summer the pond dries up and the deer destroy the lower plastic fence that is being used to try to keep them out. I will be looking for quotes in the next few months. We would need 700 LF of fence installed. As you are all aware, deer inside the airport is a safety hazard.

- The first two window screens I ordered as a test have arrived and they are a good fit and good quality. The remaining screens have been ordered to keep the airflow inside the terminal this Summer while keeping the bugs out. The AGRCP-CRRSSA Grant for \$13K the Port received will be used for reimbursement to the Port.

## POSSIBLE LAND PURCHASE VIERTHALER

- The FAA has now approved the Master Plan. All closeout paperwork is in the works with DOWL and FAA. I have not received an answer back from the FAA if they are interested in helping the Port purchase the Vierthaler property.

## PAPI DESIGN AND CONSTRUCTION AND MOS

- We are currently in the reconciling phase of data between the survey team that came to the airport, and the aerial flight that has already happened.

## WETLAND MITIGATIONS

- No report yet from Wetlands Resources, who was here on 5-20-21. I will update when we get the report. - **Correction. We only get annual report.**

## OLD BUSINESS

- The airport has a list of 24 hanger requests, and we have had a request to start building more hangers. The FAA has asked us to order an Environmental Assessment on the SE corner (old dog park area) in 2022.  
UPDATE-The FAA will be joining in on the July meeting to discuss other options of a new study for West side construction as this will help the Port with the list of people waiting for hangers.
