

MANAGER & FACILLITY REPORT 2022 JANUARY

- Thank You Pierrette for your time as Commissioner here at the Port, we really appreciate the work you did.
- Welcome Jason Laursen to the Port Commission. We look forward to good things to come.
- 2021 Enplanement totals are 9028 We will be receiving \$1M in Enplanement AIP funds because of a two year offer from the FAA during the slower Covid years.
- The Vierthaler property reports for Wetlands and Environmental are completed. Estimate appraisal will be around February or March. The pond located on the property was determined to be man made and used to be farmland.
- The 3-year state audit will be final late January.
- Continued attention to deter the increased number of seagulls and geese around the airport.
- Meryl with Wetland Resources determined that a clump of trees that are located at the South end of the runway on private property can be removed or topped for safety. They are outside of wetlands and buffer areas and are posing a threat to arriving and departing aircraft and they are on the Ports ALP as an obstruction. The homeowner has agreed to let the Port remove the trees.

FACILITY REPORT

- It was a difficult Dec and into January with snow and ice for the airport with several runway closures. I will be working with a plow company going forward to help with snow removal quicker.
- The FAA stated that the bi-plane hangar does not fall into a historic building category and the environmental came back as CatEX (categorical exclusion) meaning they see no concern of environmental issues removing the building. The Port can proceed with removal in late 2022. I will work with WHPacific for this project.
- I will be receiving a fuel delivery this month. Prices will be going up a bit, but I don't have a new figure at this time.
- The Girot access gate onto the taxiway continues to be an issue when the wind blows. We are going to send pictures and measurements to the gate company and talk about other solutions to keeping the gates closed during windy days.
