

MANAGER & FACILLITY REPORT 2022 FEBRUARY

- FAA will not allow land swap until Westside Planning and Drainage Study is company.
- 2021 Enplanement totals are 9391 FINAL. Airlines are not required to report them, so I will be asking them all soon to report to the FAA. I emailed all of them to ask them to report by March 18, 2022
- The Vierthaler property appraisal was done. Appraisal report is now done and will now be review by an independent company, then go into negotiations.
- Geese are a big problem currently; however, they are not around by 8 AM when I arrive so I can't chase them away. They are visiting the airport at some point in the middle of the night, and they are making a mess on the taxiway. James has been using the leaf blower to remove it all.
- I received our CIP report from the FAA an see that project like the Westside Environmental have been pushed out so I am working with them to see what we can do about it. I was under the impression that we were starting this year. It may still happen if me and our consultants can gather some information before April 2022.
- I have corrected information about the BIL Grant Orcas Airport was awarded as part of the Bipartisan BIL for Infrastructure, in the amount of \$1,005,969. The Port will receive this amount 5 years in a row. It may be slightly adjusted each year. We can use the funds awarded each year or wait and save up for a larger project at the end of the 5 years. It is to be used like all other approved FAA projects.

FACILITY REPORT

- I received a call back from Gateway Controls about the Griot gate, stating they will
 come out with a few parts that might be the issue of the gate staying opened, like
 old gear boxes. They may also decide to install a flush track in the future after
 doing a bit of maintenance.
- Car charger-I spoke to ChargePoint company, and they said now that I have activated the charger no one will need to download the app, and they also stated that we don't need WIFI to get the full 50 amps it can do. I just need a test person. It will take approx. 4 hours to get approx. 30 kwh of recharge.
- I have asked three companies to give quotes for new roofing, but I have not heard back from any of them.
- The Wetland Mitigation 2-year study is on the website.
- The dog park lean-to is going to be moved to the new dog park when it dries up a bit. They are working on the foundation for the new site now.
